## Attic/Ceiling Rebate Application

### ELIGIBILITY:

1. Applications are subject to verification. The rebate will not be paid if the verification cannot be completed
2. The installation address must match the address on the active BPUB electric services account
3. The application and supporting documents must be completed and submitted within 45 days of installation.
4. The rebate recipient (tenant/property owner) must be a BPUB customer. Property ownership will be verified using county tax records
5. Only one application is accepted per address per fiscal year (October 1 through September 30).
6. BPUB may discontinue the program at any time. Rebates are contingent upon fund availability

### PROGRAM TERMS AND CONDITIONS:

1. Rebate Amount =  $(\$0.01) \times (\text{square foot of insulated space}) \times (\text{R-value added})$ ; up to \$500.
2. To qualify, attic insulation must be installed between a home's main area in conditioned (air-conditioned living area below the ceiling) and unconditioned areas (attic); garages and other non-conditioned rooms do not qualify.
3. The Final insulation must have an R-value of:
  - a. R-38 for Batt, Blown-in, or Rigid
  - b. R-23 for Spray Foam
    - i. Polyurethane spray foam (closed-cell) applications shall be a minimum of 5 inches thick when applied to the interior roof deck.
    - ii. Polyisocyanurate spray foam (open-cell) applications shall be a minimum of 5.5 inches thick when applied to the interior roof deck.
4. The insulation installer will determine and be required to document each home's current insulation level on the invoice. The degradation due to the age and density of the existing insulation should be considered.
5. Rebate only applies to the newly installed insulation.
6. Provide the Property number from Cameron Appraisal District. Square footage measurements will be verified against Cameron County Appraisal District <https://www.cameroncad.org/property-search>
7. An itemized and dated invoice from the contractor or retailer must include the manufacturer, the type of insulation, the existing R-value (if applicable), the R-value installed, the square footage installed, and the installation address and date.

### PROGRAM INSTRUCTIONS:

You must meet both Eligibility and Program Terms and Conditions.

1. Complete the entire Insulation Residential Rebate application.
  - a. Option 1: Complete the application online. We suggest using this method to receive automatic updates.
  - b. Option 2: Deliver the application and supporting documents to 1425 Robinhood Drive. Automatic updates are not available. Please keep a copy for your records
2. Provide an itemized and dated invoice from the contractor or retailer. It **MUST** include the manufacturer, the type of insulation, the existing R-value (if applicable), the R-value installed, the square footage installed, and the installation address and date.
