## Duct Performance Rebate Application

### ELIGIBILITY:

1. Applications are subject to verification. The rebate will not be paid if the verification cannot be completed.
2. The installation address must match the address on the active BPUB electric service account.
3. The application and supporting documents must be completed and submitted within 45 days of installation.
4. The rebate recipient (tenant/property owner) must be a BPUB customer. Property ownership will be verified using county tax records.
5. Only one application is accepted per address per fiscal year (October 1 through September 30).
6. BPUB may discontinue the program at any time. Rebates are contingent upon fund availability.

### PROGRAM TERMS AND CONDITIONS:

1. The rebate is for replacing existing ductwork or repairing and improving existing ductwork; it is for retrofit only.
2. Before commencing any work, the customer is required to pay for the pre-test cost through a Home Energy Rating System Rater (HERS). If the rebate is approved, the customer will receive a credit of up to \$125.00 applied to their account for the cost of the pre-test.
3. Pre-testing must show 20% or more leakage in the duct system.
4. Post-testing of the repairs and replacement must show 10% or less leakage in the duct system.
5. The first duct blaster test establishes base leakage, and the second test establishes results. All results must be sent to BPUB. Duct testing must be done to show energy-efficient improvements to the system.
6. The customer is responsible for ensuring compliance with all federal, state, and local regulations for the installation.
7. The work must be done by a licensed Texas Air Conditioning Contractor (TACL). TACL number must be provided on the application.
8. A legible copy of the purchase receipt that includes the installation address and installation date.
9. Rebate will be in the amount of 25% of costs up to \$500.
10. BPUB will pay for the final testing of the system up to \$125.00.

### PROGRAM INSTRUCTIONS:

#### **Ensure you meet both Eligibility and Program Terms and Conditions.**

1. Complete the entire Duct Performance Rebate application.
  - Option 1: Complete the application online. This is the preferred method so you can get automatic updates.
  - Option 2: Deliver the application and supporting documents to 1425 Robinhood Drive. Automatic updates are not available. Please Keep a Copy for your records.
2. Provide a legible copy of the purchase receipt, including the installation address and date.
3. Submit the pre-testing results from a HERS Certified Rater.
